deconstructing the Collse M

Dear civil government school teacher:

I am a Christian. As such I assume Scripture is the source of all wisdom and knowledge and then I reason from Scripture. More specifically, God reveals to us in Scripture that in Jesus Christ are hidden all the treasures of wisdom and knowledge. Jesus Christ is therefore the foundation of a true education, including one that properly informs us of the civil government's limitations and true purpose.

Since you work for the civil government school system, you are not likely aware that God precludes the civil government from operating a school system. The civil government has jurisdiction (lawful authority) over only actions.³ In that regard civil government is to execute God's wrath upon evildoers and promote (not provide) good.⁴ The civil government has no jurisdiction over a person's thoughts, and therefore operating a school system is beyond their jurisdiction. Moreover, the Bible does not justify property taxes (which fund civil government schools), nor does it justify compelling someone to attend what amounts to a *de facto* church – no matter the doctrine.

Understand that God commands parents to teach their children the Christian worldview.⁵ Although some fail to exercise that *duty owed to God* ("right"), parents cannot abdicate that responsibility. Understand that the civil government must protect the God-given right to raise one's child in the nurture and admonition of the Lord. The civil government, as it stands, is not protecting that right; they are interfering with it.

While parents have the right to teach their children the Christian worldview, they may delegate that duty to another. Even in that situation, however, parents are still in control of the child's education, and still responsible before God as to the substance of that education. In exercising that right then, parents must delegate wisely.

For my child's benefit, and for my own as I eventually will account to God for my child's education, I present the survey below to you, so that I may properly determine whether you are fit to be my delegatee as I raise my child in the nurture and admonition of the Lord.
